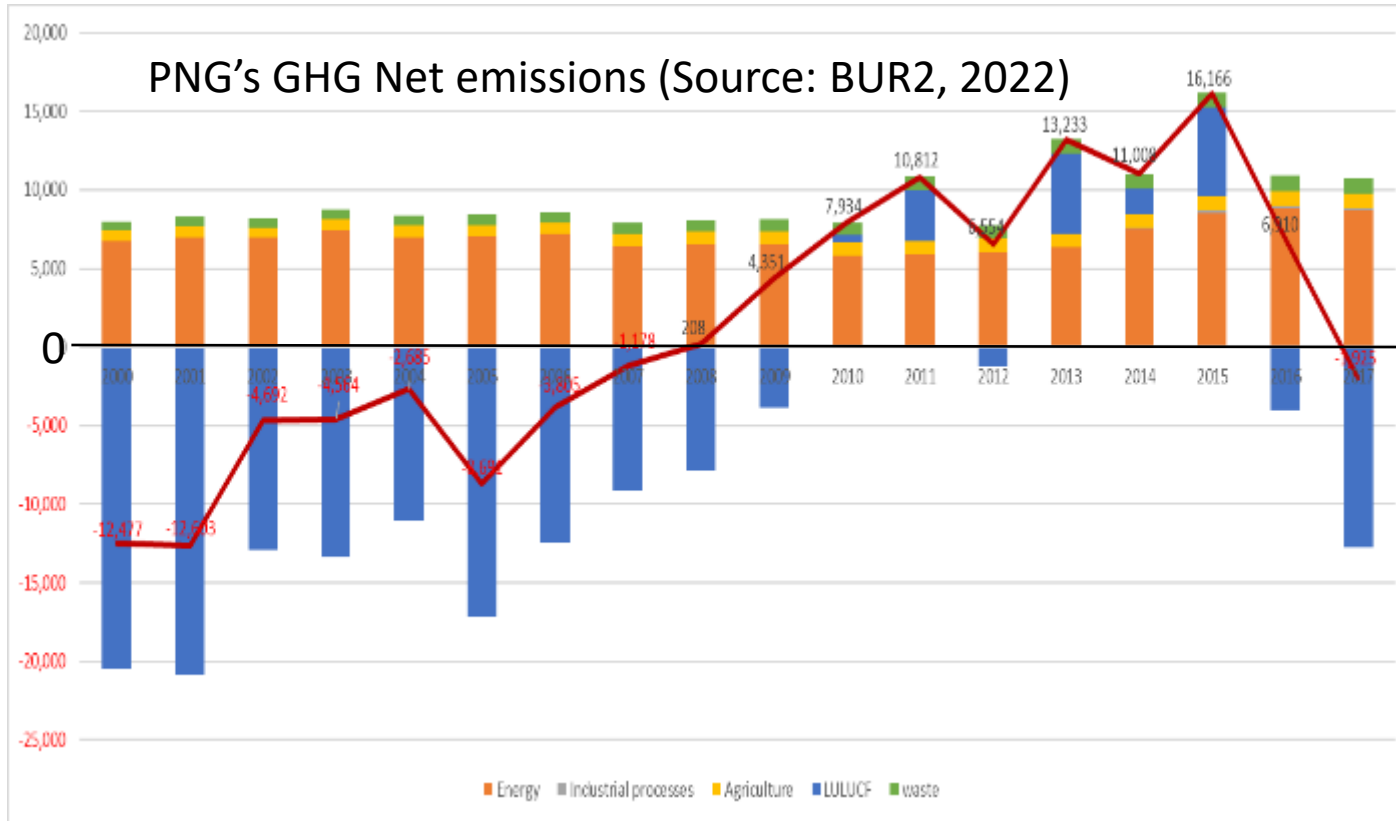

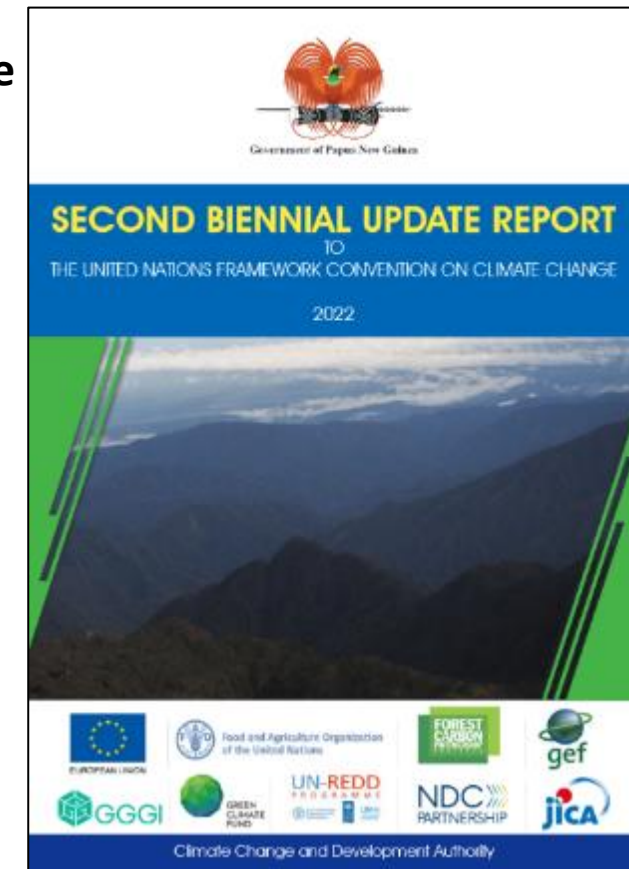
# PNG is a net-zero emission country

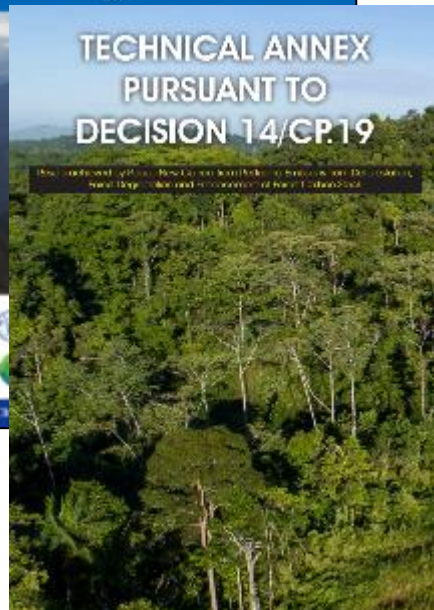
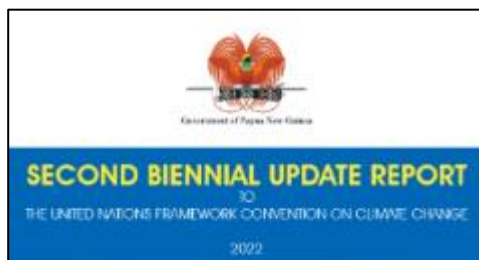
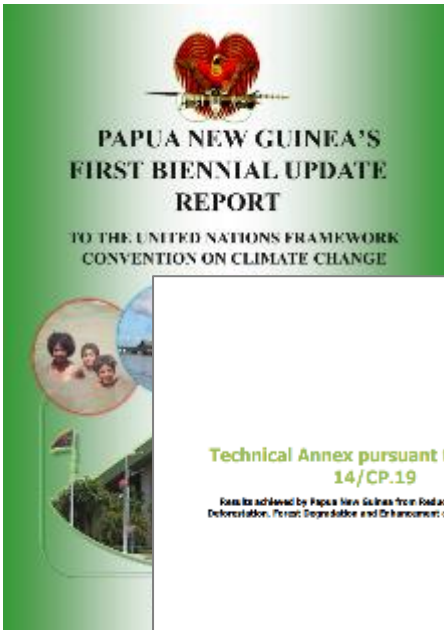
## UNFCCC's Technical Assessment Report

The technical analysis concluded that the data and information provided in the technical annex are in **overall accordance with the guidelines** contained in decision 14/CP.19 and **overall transparent**.

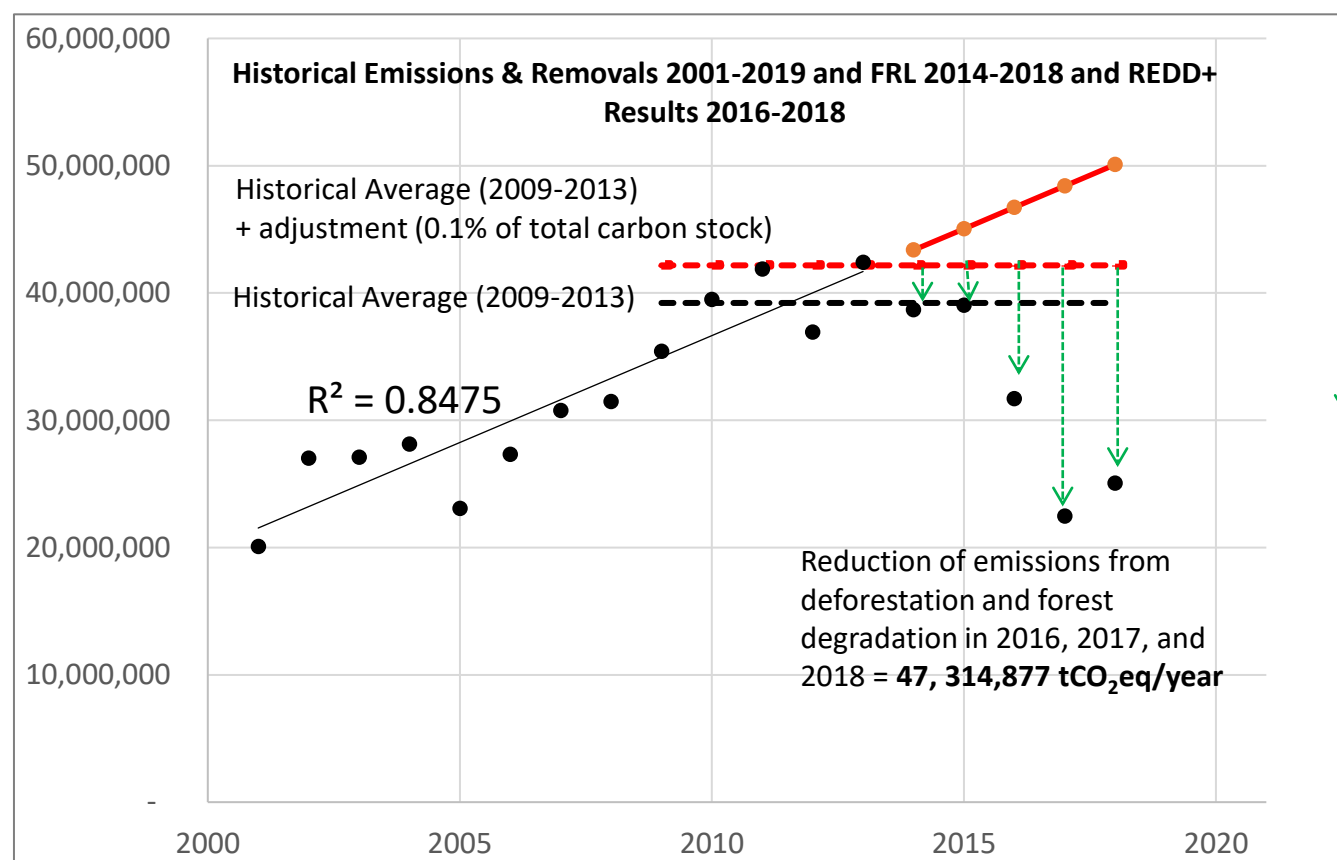
## REDD+ Results Based Payment Pilot Programme – PNG Proposal

- PNG submitted its concept note to the GCF in **December 2019**, factoring in results from **2014 and 2015 amounting to a reduction of 6.5 million tCO<sub>2</sub>e**.
- However, the funding for this program was fully utilized two years before its conclusion, leaving four proposals, including one from PNG.
- Recognizing the need to continue supporting these initiatives, GCF has approved a second phase of the RBP program. In July 2024, ensuring funding availability for the four countries including PNG that were previously unable to receive payments.
- Under the new phase of the GCF RBP programme, PNG is considering extending the claim **to include results of 2016 in addition to 2014-15** in the original CN, **totalling a reduction of 17 million tCO<sub>2</sub>e**.

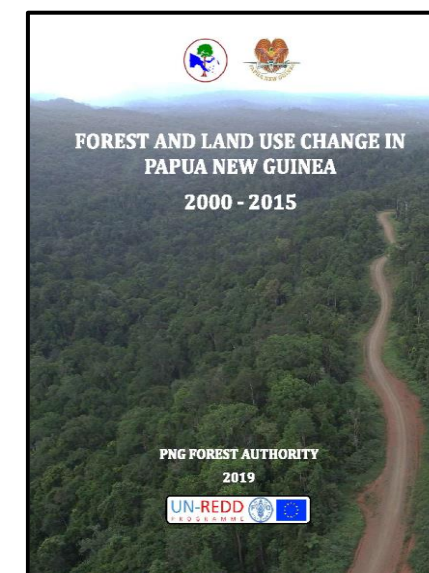
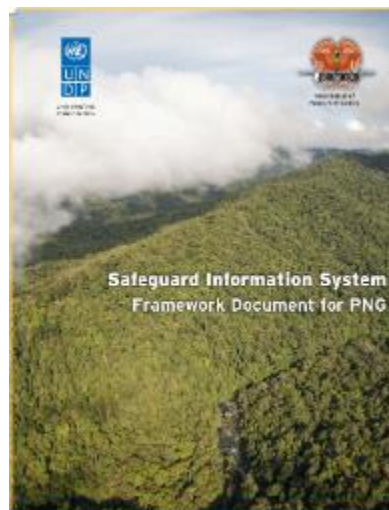

# Existing and pipeline legislation

- Domestic legislation

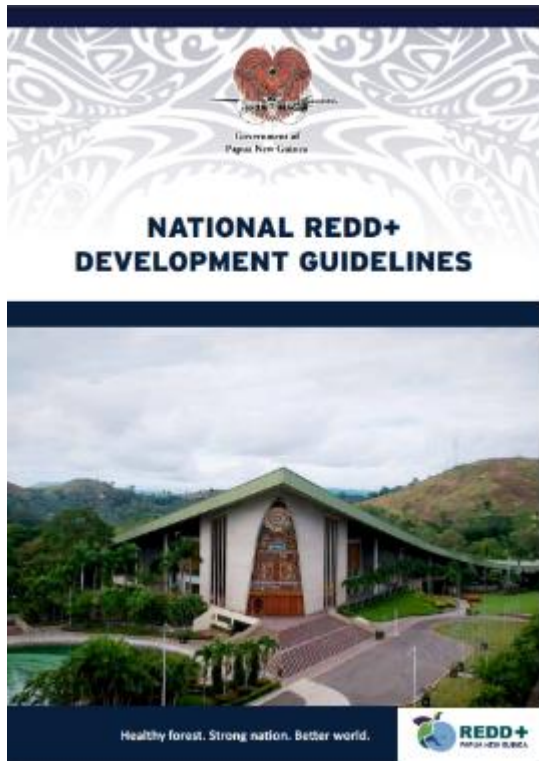
- PNG's *Constitution of 1975*, which enshrines customary land tenure and supports the conservation of PNG's natural resources and environment;
- land law, in particular the *Land Act 1996*, the *Land Registration Act 1981* and the *Land Groups Incorporation Act 1974*;
- *Forestry Act 1991*;
- *Organic Law on Provincial and Local-Level Government 1998*;
- *Climate Change (Management) Act 2015* (CCM Act), which establishes key institutions including the Climate Change and Development Authority (CCDA), the National Climate Change Board and the Climate Change and Green Growth Trust Fund. This Act also recognises landholders rights, provides for benefit sharing and the allocation of incentives for climate change related projects, and the entry into climate change related project agreements;
- Domestic legislation relevant to the management of public money, including the *Public Finances (Management) Act 1995*, the *Investment Promotion Act 1992* and the *Fiscal Responsibility Act 2006*;
- provisions in the *Oil and Gas Act 1998* relating to agreements with landholders and benefit sharing; and
- Relevant policies and other instruments, including PNG's Nationally Determined Contribution (NDC) under the Paris Agreement, National REDD+ Strategy 2017-2027.



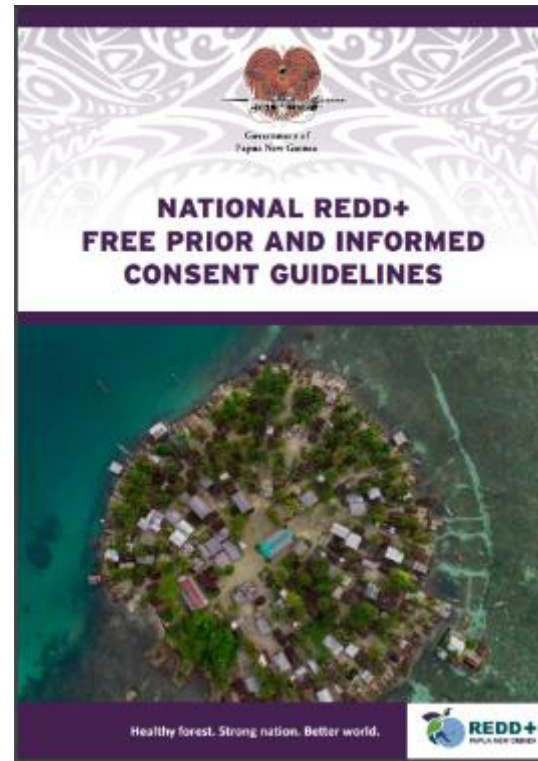
